Fire Department Report

Jerry McClary gave the report for Fire District activities this month:

- 708 total runs for the year-Leesburg-229, Liberty-193, Taylor-114, York-70, Mutual aid-173
- The District hired a Chaplain-Gene Miller to assist with the employees
- They will start taking bids for the Leesburg station addition on 12/17
- A car ran into the Raymond station causing damage to a pillar which will result in an insurance claim.

Zoning department report

Zoning inspector Terry Turner reported that he has received 4applications and has issued permits and denied 0 permits this month. He had around 31 calls for the month, 28 incoming emails and 19 outgoing emails. The BZA had its most recent regular meeting on November 18, at the Community Building and would like to continue using it for meetings in the future if this wouldn't be a problem. The next regular meeting will be January 6, 2026.

Solar Projects

The pilot payments that were scheduled to be starting in 2026 will not be starting until 2027. Cadence has done nothing regarding drainage. The maintenance and operation building is under construction.

Old Business
